

Guest Speaker Agreement

Shirlene Reeves (from here on in referred to as Host) will record _____ (from here on in referred to as Expert) for a video/audio interview. The Host may edit the recording at their discretion, and shall own the worldwide rights, title, and interest, including copyright in, and of, the Expert's recording. However, *Expert has the right to use his or her recorded interview for any purpose. The material shared in the interview, by the Expert, is and shall remain, the sole copyright of the Expert.*
6. Expert represents that he or she has the full right, power, and authority to grant this release and to perform all of the provisions described herein. Expert agrees that in the event of a breach or alleged breach with respect to the terms and provisions of this agreement, that The Host shall be entitled to such injunctive or equitable relief as the Host may deem appropriate, in addition to other legal rights the Host may have.
7. Expert agrees to indemnify and hold harmless the Host from and against all claims, losses, expenses, and liabilities of every kind including reasonable attorney's fees arising out of the inaccuracy or breach of any provision of this Agreement. Expert expressly releases the Host from any and all claims arising out of the use of the material.
8. This release shall be governed in accordance within San Diego County, California laws and all mediation shall take place in that county regarding any and all claims arising out of the use of the material.
9. This release constitutes the entire agreement between the parties and supersedes any and all agreements of any kind previously made by the parties involved.
